- ID cards the process is still on-going and adv Sean Kelly reported that corrections

- 3. Constitution a revised constitution is in process. The Vice-chairman adv Koot Myburgh is the project leader in this regard with his experience in the field of writing constitutions. - 7. Resignation by adv Van Gend Botha as Treasurer adv Van Gend has been appointed as an ombudsman in the Northern Cape to facilitate property disputes in Katu, Postmansburg and surrounding areas. As a result he has resigned from his position. We would like to thank him for his contribution as Treasurer and wish him good luck in his new appointment. Adv Pierre Louw has been appointed in this position for the remainder of 2018.
- 8. Feedback on the Legal Practitioners Act feedback has been distributed to the members of the Society. The issues are basically that the National Forum is requesting an extension of time and that there is a dispute about fee structures. We will inform members of any further developments. Adv Neels Killian, our librarian has indicated that he would investigate further and sent any information to the secretary for distribution.
- 9. Accreditation with the office of the State Attorney we are awaiting our application in this regard.
- 10. Letters of Good Standing the secretary has been authorised to issue such letters in consultation with the Chairman.
- 11. North Gauteng Bar on 31 July 2018, this bar has been dissolved due to the small number of members. A meeting is to be set up as soon as possible to discuss the implications for the dissolved North Gauteng Bar. Our Society is well known with their members and the conditions are that the members apply for membership, be incorporated into our Society but that our

society would have nothing to do with their finances, credit providers or whatever.

We will interview and accept members on merit.

For this reason the Federation has been non-active for some time and the principle

is still that should there be a concern or aspect of mutual interest, we could

approach any such matter under this forum.

at 'Diep in die Berg'. The session will start at 09:00 am to 13:00 pm. The topics for

the session are lectures on evidence, jurisdiction and the use of and effect of

specialised / expert evidence in criminal trials. Members who wish to attend this
